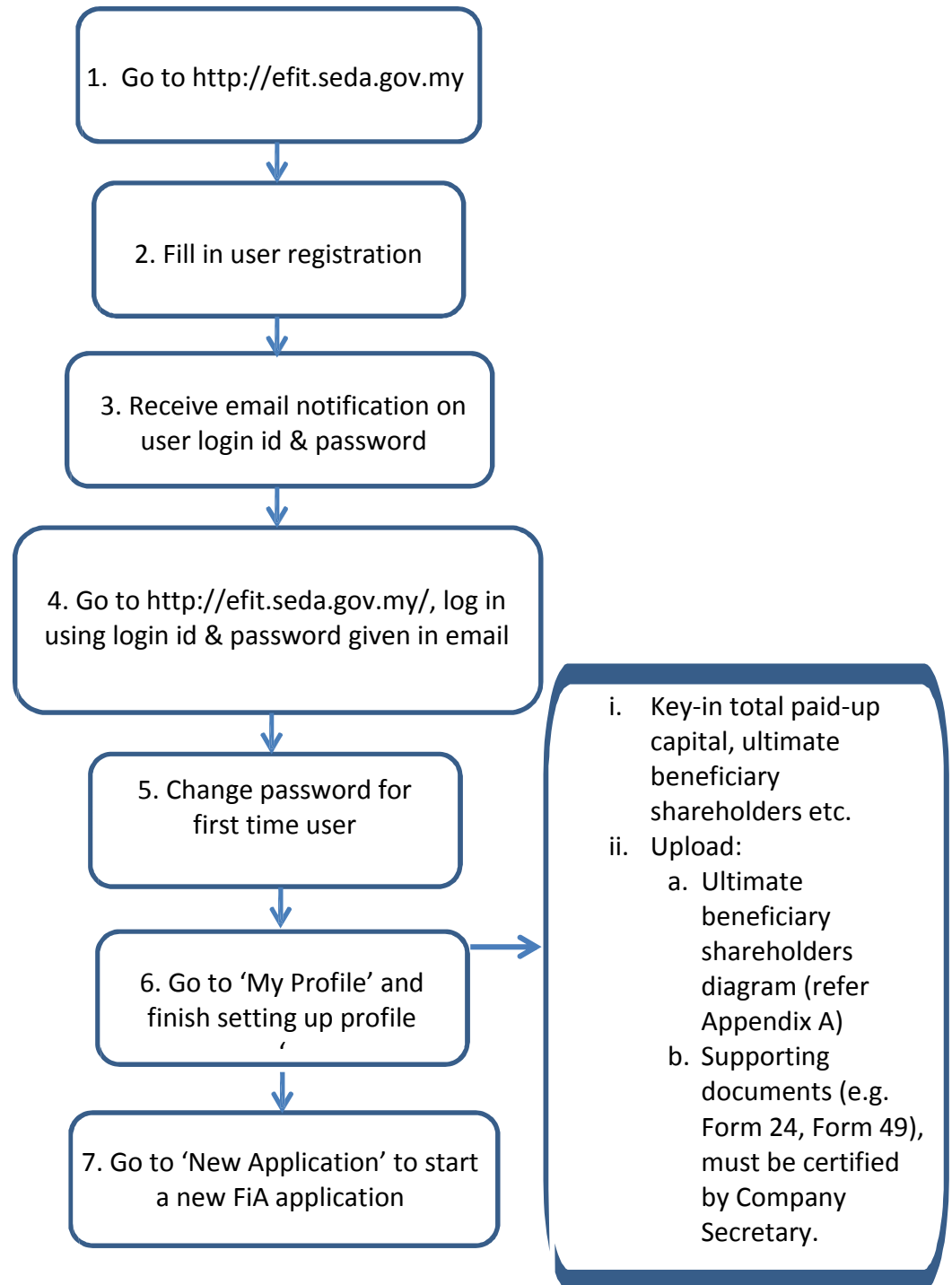

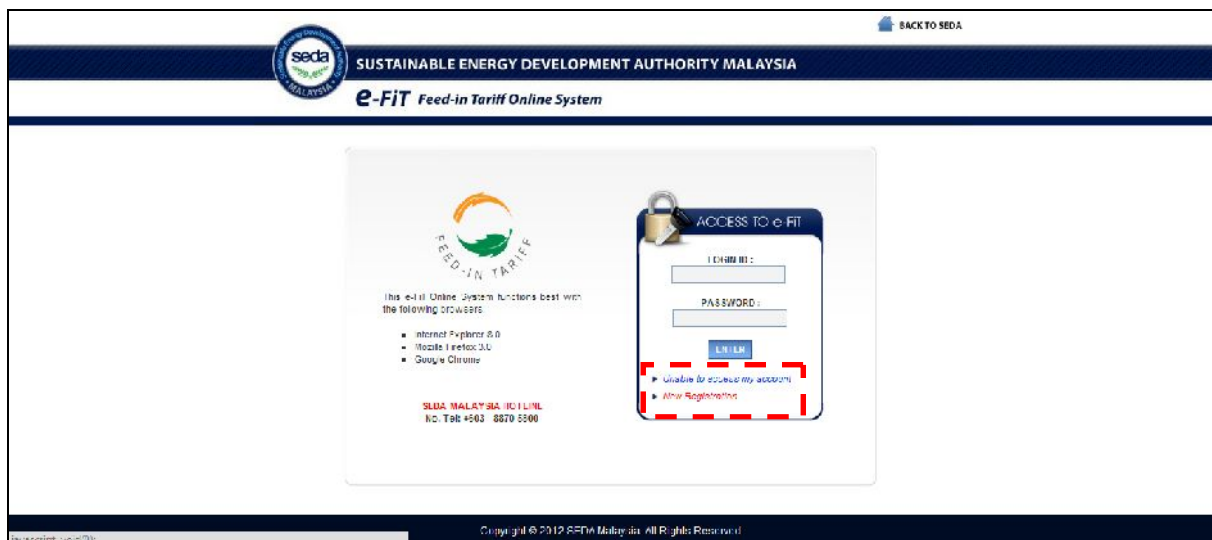
You will have to go through a simple 7-step process before you can start your feed-in approval (FiA) application. The 7-step process is presented in the following flow diagram:



1. Go to <http://www.seda.gov.my/> and click to login button or go to <http://efit.seda.gov.my/>. If you are using the e-FiT online system for the first time, click on the 'New Registration'.

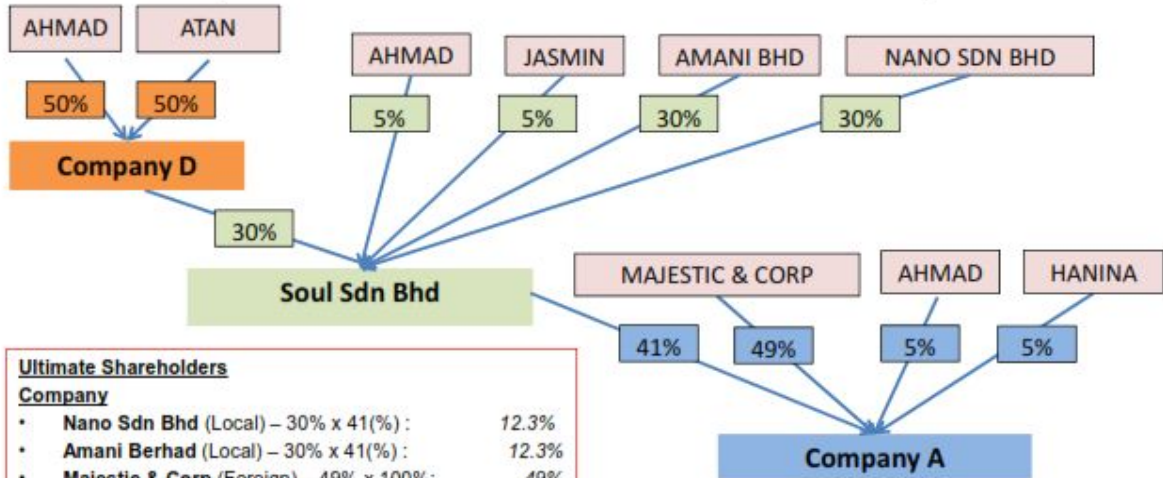
